OVERVIEW:

This is a full day with Dr. Joan B. Kelly which will be of interest to professionals working with divorced and separated parents including family lawyers, therapists, psychologists, mediators and parenting coordinators. In the morning, Dr. Kelly will be discussing the controversies surrounding “Parenting Plans for Very Young Children” focusing on research which she has not previously presented, on early infant attachment, early father involvement, and overnights for young children. The afternoon is an interactive dialogue with Dr. Kelly and other special guests. There will be a chance to participate in a discussion with a diverse group of professionals on parenting plans, progress made in the area, practice issues, and questions you want answered by an internationally known expert on children and divorce, along with a view from the bench.

KEY SPEAKER: Dr. Joan B. Kelly, PhD.

Dr. Kelly is a psychologist, researcher, and mediator. Dr. Kelly received her PhD in Clinical Psychology from Yale University. Since 1970, her research, clinical, and teaching career has focused on child and family adjustment to divorce, custody and access issues, and divorce and custody mediation. She has been honored for her work with many awards, including the Distinguished Mediator Award from the Academy of Family Mediators, Fellow of the American Psychological Association, and the Stanley Cohen Distinguished Research Award from the Association of Family and Conciliation Courts

Dr. Kelly is a frequent keynote speaker, workshop leader, and trainer at national and international conferences, including the Association of Family and Conciliation Courts, American and California Psychological Associations, Academy of Family Mediators, Family Mediation Canada, Society for Professionals in Dispute Resolution, Family Mediation Associations in England, Ireland, and Scotland, and the New Zealand Psychological Association. She has presented children's divorce adjustment, child development, and mediation seminars in Australia, Canada, Denmark, England, Iceland, Israel, New Zealand, Norway, Scotland, Spain and Sweden.
